

User Agreement

This User Agreement shall govern relations related to use of website <http://www.gladtoeu.com/> (the "Site"), serviced by OOO MediaContentGroup (the "Company") between the Company and individual (the "User").

This Agreement is public offer of the Company.

Registration of the user on Site shall confirm his accession to the Agreement.

The User accepting the Agreement shall:

1. Confirm that he had a look at the Agreement.
2. Guarantee that he is 18 years old or more.
3. Be personally liable for information and photographic material content published by him on the Site, for safety and confidentiality of details required for his registration on the Site.
4. Be aware that the Site may include materials aimed at the Users of full age only.
5. Be obliged to use the Site in compliance with the laws in force and applicable in such an area.
6. Be obliged not to publish e-mail addresses, postal addresses, telephone numbers, links, and other contacts in public.
7. Be obliged not to publish offensive language, slander, effing and blinding, pornographic or other unmoral materials; materials demonstrating or propagandizing cruelty, terror or forcing; materials outraging human dignity; and other materials out of the law.
8. Be obliged not to misinform other users, and not to run after or annoy them; not to come in contact with other Users in case other Users do the actions clearly showing they have no wish to contact with the User.
9. Be obliged not to do any actions or offer to other Users to do the actions regarding any goods, works or services, use the Site, to distribute advertising materials or illegal propaganda materials.
10. Transfer to the Company exclusive right to distribute, translate or modify, as well as inform about materials loaded by the User to the Site or otherwise given by him to the Company by cable, wires, or by other similar means, in such a way that any person may have an access to it in interactive (on-line) mode from any place and at any time at his discretion (right to give public notice).

The Company shall reserve the right to:

1. Modify the Site at his disposal.
2. Render paid and free services to the Users (the "Services").
3. Make changes in the User Agreement unilaterally.
4. Edit or delete material published on Website by the Users if the same are inconsistent with terms and conditions of the Agreement, do harm to the Company or third persons.
5. Use private details of the User, and materials published by the User on the Site and on open access, in particular, with a view to develop advertising materials (as a collage only), place the materials on sites of the Company's partners, and for other purposes.
6. Transfer the rights received from the User hereunder, to third persons to execute this Agreement without further consent of the User.

The Company shall not be responsible for:

1. Content, authenticity, and accuracy of materials published by the Users.

2. Infliction of harm, damage, loss of the information or for any other losses to any persons arisen in the course of operation of the Site, including related to use of mobile or other communication facilities.
3. Violation of copyright or other rights of third persons by the User by publishing of materials inconsistent with the legislation in force (including copyright law) loaded by the user to the Site or otherwise transferred by him to the Company.
